REVIEW ENGAGEMENT REPORT

To the Minister of Aboriginal Affairs and Northern Development Canada:

We have reviewed the Schedule of Salaries, Honoraria, Travel Expenses and Other Remuneration, of Elected Officials (as outlined in Section 7.3 of the Year End Reporting Handbook for fiscal year 2014 - 2015 from Aboriginal Affairs and Northern Development Canada), for the year ended March 31, 2015. 


